Purpose of the Study

The purpose of the study is to analyze the actual financial impacts as a result of the pandemic on vulnerable taxes in Virginia (i.e., meals tax, sales tax and hotel tax).

The results are set for publication in the Municipal Finance Journal in early Fall 2023.

Analysis utilized audited financial information obtained from the Auditor of Public Accounts for fiscal years 2017, 2018, 2019, 2020 and 2021.

What do we know?

- Local government revenues are impacted differently depending on the types of emergencies
 - September 11 Attack property tax revenue not impacted, sales tax including tourism related spending declined for two fiscal years after attack.
 - Great Recession property tax revenue significantly declined and lagged in recovery for a number of years (due to reassessment cycles, tax rates, etc.) and sales tax declined but rebounded within two years.
 - Hurricanes sales tax revenues increased immediately after the hurricane and then decline for up to two years.
 - Pandemic? That is the question we are trying to answer in the study.


Question 1

How important were sales taxes, meals taxes and hotel taxes to cities, counties and towns in Virginia prior to the pandemic?

Summary

Sales taxes were relatively more important for cities and counties, while meals taxes were relatively more important for towns.

What happened to total local revenues in Virginia during the pandemic?



Summary

While total local revenues generally increased for all localities, about a third experienced a decline in total local revenue in FY20.

About half of localities experiencing a decline in total local revenues in FY20 were towns.







Summary

Sales taxes increased every year from FY17-FY21.

• Sales taxes increased most in FY21, with larger increases occurring in cities and counties.

Meals taxes declined in FY20, but rebounded in FY21.

• Only towns were able to collect more meals taxes in FY21 compared to FY19.

Hotel taxes declined in FY20, and again in FY21.


• Only counties were able to avoid declines in hotel taxes per capita in FY21.

Virginia Demographic Regions Map



Per capita changes by region FY19-FY20





Summary

Localities in the smaller and more rural Eastern region generally performed the best in the fiscal years following the pandemic.

Localities in the Northern and Central regions generally performed the worst with respect to the meals tax and hotel tax in the fiscal years following the pandemic.

 These declines did not seem to affect local revenues in these regions very much, which is likely due to the fact that cities and counties rely less on these tax streams for their local revenues.

Policy Challenges and Considerations

Meals taxes are the second largest source of revenues for Towns (21%) of total revenues. The pandemic revealed the inherent risks of high reliance of meals taxes.

Towns should consider ways to diversify revenues in the future.

Policy Challenges and Considerations

Average town population is 2,761 persons.

Residents of towns pay both town and county taxes which puts additional pressure on town officials to maintain low tax rates.

Town populations represent on average only 4.85% of a county's population; smaller voice relative to county voters

Policy Challenges and Considerations

Not all counties have adopted a meals tax. As of FY2021, 48% of counties did not adopt a meals tax.

Virginia Counties Adopting the Meals Tax



What do we know now?

- The pandemic impacted vulnerable taxes significantly.
- Sales tax over all did not decline; sales tax increased every year from FY17 to FY21.
- Meals tax declined in FY20; but rebounded in FY21.
- Hotels taxes declined in FY20 and FY21.
- Property taxes were unaffected.



Tax Sources as a Percent of Total Local Revenues (FY17-FY21)








