

The 27th Annual
Virginia Water and
Wastewater Rate Report
2015









Virginia water and wastewater providers were asked to provide information concerning the monthly residential water and wastewater bill based on consumption of 5,000 gallons of water (or 670 cubic feet) per month and to include all water and wastewater-related charges listed on the customer's bill. The survey provides residential rates both inside and outside of municipal boundaries where applicable. It also asked questions concerning rates for non-residential customers using one million gallons per month. Data for connection fees and capital recovery charges were also gathered. Our special topic this year included questions relative to wastewater facilities and septage charges.

For the past 20 years the survey has featured a control group comprised of 20 water and wastewater providers who represent a cross section of utilitites across the Commonwealth. The information in the table below is reflective of the data collected from this group. The rates shown indicate residential charges based on consumption of 5,000 gallons per month.



According to the results of this year's data, the combined average residential water and average residential wastewater rate increased 2.4% from 2014. Over the past ten years the combined average water rate and wastewater rate increased by 71.3%.

What Keeps You Up At Night?

This year's survey offered an opportunity for participants to identify their top concerns about their services and/or facilities. The responses fell into seven (7) categories:

- Infrastructure Concerns,
- Operating and Maintenance Costs and Rates,
- gulations and Regulatory Compliance,
- Water Quality/Quantity, and Customer Service.

Almost 60% of the respondents cited infrastructure concerns or the rising operation and maintenance costs and the impact on user charges and fees. Approximately 25% of the responses indicated concerns about maintaining regulatory compliance or concerns with wastewater treatment.

Septage and High-Strength Waste

Septage or Truck-Hauled Waste

This year our special topic focused on items concerning wastewater treatment. We asked several questions about facilities that accept truck-hauled waste. Of the 115 respondents that answered this section of the survey, 49 or (43%) indicated that truck-hauled waste was accepted at their facility.

The following utilities who responded to the wastewater questions are provided wastewater treatment services by the Hampton Roads Sanitation District (HRSD): the City of Chesapeake, the City of Hampton, Isle of Wight County, James City Service Authority, the City of Virginia Beach, the City of Williamsburg, and the Town of Smithfield. The survey questionnaire asked these utilities to include the HRSD wastewater treatment charges in their responses. As a result, the data listed for these utilities includes \$27.67 per month for residential customers using 5,000 gallons (or 670 cubic feet) of water per month and \$5,534.20 for non-residential customers using 1,000,000 gallons (or 134,000 cubic feet) of water per month. Additionally, where connection charges or capital recovery charges are listed, the HRSD facility charge of \$1,895 is included.
