Betsey Daley

Staff Director, Senate Finance Committee

Betsey Daley has served as director of staffing for the Senate Finance Committee for 13 years, coordinating the development of the Senate budget and initiatives related to tax reform, higher education restructuring, and transportation. She has an established record of public service; prior to coming to the Senate Finance Committee she worked in the Governor's budget office and in the budget office of the University of Virginia. As a staff member of the Senate Finance Committee, she acquired extensive expertise in the areas of higher education and capital outlay while developing the 2002 "Building Virginia's Future" capital outlay program, and staffing the Joint Subcommittee on Higher Education Funding Policies, which established new funding guidelines for Virginia's public colleges and universities. Betsey served as Chair of the National Association of Legislative Fiscal Offices (NALFO) for 2012–2013 and worked diligently on initiatives and programs to improve the quality and effectiveness of legislative fiscal staff and the services they provide to state legislatures.
