## Who Has Broadband Service?

- Multiple Studies/Stories Demonstrate That Mapping Programs Used By Carriers Were Insufficient To Identify Underserved Areas
  - ISPs Were Counting An Entire Census Block As Being Covered By Service Even If Only A Small Area Was Covered
- August 2019 FCC Adopts "Digital Opportunity Data Collection" Service
  - Requires Detailed Geospatial Maps Of Coverage Areas, Instead Of Census Blocks

### ReConnect Program

- Consolidated Appropriations Act of 2018
   Establishes Rural eConnectivity Pilot Program
- Act Appropriates \$600 Million On Expedited Basis

**ReConnect Loan and Grant Program** 

#### **Broadband Defined**

- Areas Without Sufficient Broadband Defined As
  - 90% Don't Have Access To:
    - 10 Mbps Downstream
    - 1 Mbps Upstream
- Applicant Must Propose:
  - 25 Mbps Downstream
  - 3 Mbps Upstream
- 100% Loan, 50% Loan / 50% Grant Or 100% Grant Available



## Funds May Be Used For

UNDER

- Construction Or Improvement Of Buildings, Land And Facilities To Provide Broadband
- Reasonable Pre-Application Expenses
- Fund Acquisition And Improvement Of Existing System Currently Providing Insufficient Service (Loan Only)
- Terrestrial-Based Facilities To Support Provision Of Broadband Service

## Funding Limits

- 100 Percent Grant
  - Up To \$200 Million Available
  - Max Grant Is \$25 Million
  - Applications Due April 29, 2019
- 50 Percent Loan / 50 Percent Grant
  - Up To \$200 Million Available
  - Max \$25 Million Grant / \$25 Million Loan
  - Applications Due May 29, 2019
- 100 Percent Loan
  - Up To \$200 Million
  - Max Loan Is \$50 Million
  - Applications Due June 28, 2019 But USDA Will Evaluate And Award On First-Come-First-Serve Basis
- Application Deadlines Passed Recently



# Connect America Fund (CAF) Phase II Auction (2018)

- FCC Reform And Modernization Of Universal Service Support Programs
  - Allocates \$1.98 Billion Of Support Over 10 Years
  - Awards To High-Cost Census Blocks In States Where Price Cap Carriers Declined An Earlier Offer Of Model-Based Support And Other Unserved Areas
  - Winning Bidding Must Provide Voice And Broadband Service At Or Above Specific Performance Levels
- 5 Winning Bidders In Virginia
- Total Assigned Support \$10,892,361.26 In Virginia



# Connect America Fund (CAF) Phase II Auction (2019)

- First Round Of Funding (\$166.8 Million)
  - Central Virginia Services
    - \$28M For 10,827 H/B
  - BARConnects
    - \$4.9M For 1,734 Homes/Business
  - Empower Broadband
    - \$1.8M For 838 H/B
  - Verizon
    - \$1.4M For 421 Homes/Business
  - Verizon South
    - \$138k For 35 Homes/Business
- Third Round (\$524 Million) Of Funding In July
  - PGEC Enterprises
    - \$15,402,703 For 5,287 Homes/Businesses
  - RiverStreet Comm. Of VA
    - \$32,140,887 For 13,518 Homes/Businesses
- Virginia Not Included In First Or Fourth Round Of Funding



## FCC Small Cell Proceeding

- FCC Defines A "Small Wireless Facility"
- FCC Prohibits Local Regs That "Materially Inhibit" Provision Of Services
- FCC Prohibits Fees Above Reasonable Approximation Of Locality's Costs
  - Sets \$270 Per Facility Per Year As Presumptively Reasonable
- FCC Sets Small Wireless Facility Shot Clocks

### Small Cell Order Status

- Order Subject To Petition For Reconsideration Filed By GWTCA, In Conjunction With Multiple Municipal Leagues (Including Virginia)
- Numerous Municipalities And Carriers Sued In A Variety Of Courts
  - Cases Consolidated, Awaiting Action On GWTCA Petition
- Despite Appeals, Order Is Now Effective
- FCC Issues Public Notice Asking For Comments On Verizon Pet. For Declaratory Ruling On Clark County Small Cell Charges

## State Small Cell Legislation

- 25 States Have Implemented Similar Or Conforming Legislation
  - Arizona, Colorado, Delaware, Florida, Hawaii, Illinois, Indiana, Iowa, Kansas, Michigan, Minnesota, Missouri, Nevada, New Hampshire, New Mexico, North Carolina, Ohio, Oklahoma, Rhode Island, Tennessee, Texas, Utah, Virginia, Washington, West Virginia
  - Federal Bill Introduced

## FCC MTE Proceeding GN Docket No. 17-142

- FCC Proposes To (In Multi-Tenant Environments) In Both Wireline And Wireless Service Offerings:
  - Prohibit Exclusive Arrangements Between Landlords & Companies In Building Or On Roof
  - Require That Landlords Let Any Provider Offer Service In Their Building
  - Prohibit Revenue Sharing
- Sprint & T-Mobile Look To Include Single Tenant Buildings (Arenas) And Government Facilities (Small Cell Inside)
