## Secretary of Public Safety and Homeland Security Robert "Bob" Mosier


Gov. Youngkin appointed Bob Mosier as the Secretary of Public Safety and Homeland Security in 2022

Bob previously served as Sheriff of Fauquier County with a career spanning over 30 years in local, county, Federal Government, domestic, and international law enforcement










# Hurricane Return Intervals




# **Historical Storm Tracks**



**Cone based on NHC errors over the previous 5 years** 




# **NWS Offices Serving**



- 24 / 7 operations updating forecasts every few hours
- Responsible for localizing forecast and impacts from one jurisdiction to another
- Coordinate with the Hurricane Center and numerous other agencies during hurricanes
- Each office has 16 meteorologists, 3 electronics technicians, hydrologist and others support staff




# Keep Up With Latest OFFICIAL Forecasts and Warnings

#### **VDEM Structure**







#### Virginia Emergency Support Team – Jennifer Maul, VDEM

- Construct of 12 Lead and more than 100 supporting state agencies, bringing together the Commonwealth's whole of government response to support localities during emergencies and disasters - more than 300 trained members from government, private sector and volunteer agencies
- VDEM personnel serve in key leadership positions
- Supporting Programs
  - Commonwealth of Virginia Incident Management Team
  - Adjunct Emergency Workforce -
  - Private Sector / Critical Infrastructure
  - Voluntary Agency Liaison
- EO 41 (2019) involvement of all state agencies and employees in disaster response
- Planning
  - Situational Awareness Unit (SAU)
  - State level strategic plans
  - Local Capability Assessment for Readiness (LCAR)
  - Threat Hazard Identification Risk Assessment (THIRA)

#### **Operational Awareness and Tips** - John Northon, VDEM

- WebEOC is our system of record to place resources and supply request prior to and during events
- Having staff trained and using Crisis Track software (recovery) (these two bullets should be in the regional slides)
- VA Code 44-146.19 covers the emergency management requirements for political sub divisions.
- Shall have a director of emergency management
- Shall prepare and keep current a local or interjurisdictional emergency operations plan
- Plan → train → exercise → identify gaps → apply for grants → receive funding → fix gaps
- Emergency Management is a team sport
- Hurricanes and Tropical Storms are statewide events
- Flooding is a year round threat



#### **Emergency Management Processes** - Jack King, VDEM

- VDEM Regional Support has teams in each region led by the Chief Regional Coordinator.
- Prior to, during, and sometimes after and event, the regional office will hold a regional call, usually starting 3-4 days prior.
- On this call, the region will update on regional posture and seek information from regional partners.
- EOC status, planning actions, and anticipated needs will be requested.
- It is important to note some requests could take 3-4 days to be delivered to a jurisdiction.
- It is important for localities to let the Regional Office know of anticipated needs early so those requests can be processed.



#### Emergency Management Processes Cont. - Jack King, VDEM

- While the regional teams work with all regional partners, at the local level, the team works with the local Emergency Manger.
- Especially important when needing resources.
- All requests from a locality should go through that locality's EM and logged into WebEOC
- Bypassing the local EM could cause a delay as any request will be confirmed with the local EM before processing.
- Localities are responsible for maintaining and updating their Emergency Operations Plan (EOP).
- In event the Governor issues and evacuation order, localities are responsible for local evacuation routes if needed, and plans for getting transportation dependent citizens to shelters or transfer points.
- Localities are responsible for opening, staffing and maintaining a local shelter.



### State Shelter Plan Update - Tina Wang, VDSS

- Local shelters are the backbone of the Commonwealth's sheltering system. The state shelter plan supplements local capacity in a catastrophic event.
- For much of the pandemic, the state shelter plan called for non-congregate sheltering (hotels). This hurricane season, health guidance allows the state plan to return to congregate as the primary means of sheltering.
- State shelter partners are aligning plans with updated VDH guidance to reduce the risk of introducing and transmitting COVID-19 in congregate emergency shelters.
- VDSS, DGS, and VDEM are working to establish contracts to support state shelters in the 2022 hurricane season.

- Need to build relationships early and often
- Partners in preparedness

#### **Know Your Zone (KYZ) and Hurricane Guide**

Know Your Zone is an awareness initiative that applies to roughly **1.25 million** residents in **23 localities** along Coastal Virginia, the region of the state most vulnerable to hurricanes and other tropical storms





# Virginia Sales Tax Holiday August 5-7, 2022


Eligible Items: https://www.tax.virginia.gov/virginia-sales-tax-holiday

- Hurricane and emergency preparedness products
  - Portable generators \$1,000 or less per item
  - Gas-powered chainsaws \$350 or less per item
  - Chainsaw accessories \$60 or less per item
  - Other specified hurricane preparedness items \$60 or less per item
- <u>School supplies, clothing, and footwear</u>
  - Qualified school supplies \$20 or less per item
  - Qualified clothing and footwear \$100 or less per item
- <u>Energy Star<sup>™</sup> and WaterSense<sup>™</sup> products</u>
  - Qualifying Energy Star<sup>™</sup> or WaterSense<sup>™</sup> products purchased for noncommercial home or personal use \$2,500 or less per item
